

FACTS**WHAT DOES TITAN LEASING, LLC ("TITAN LEASING") DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ▪ Social Security number and income ▪ Account balances and assets ▪ Credit history and employment information
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Titan Leasing chooses to share; and whether you can limit this sharing.

What we do	
How does Titan Leasing protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Titan Leasing collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ▪ Apply for a lease or give us your income information ▪ Provide employment information or give us your contact information ▪ Pay your bills <p>We also collect your personal information from others, such as credit bureaus, affiliates or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ sharing for affiliates' everyday business purposes – information about your creditworthiness ▪ affiliates from using your information to market to you ▪ sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>Our affiliates include companies with a Titan name; financial companies, such as Security Credit Services, LLC, US Consumer Capital, LLC, and Action Auto, LLC; and nonfinancial companies, such as EquiPro Holdings, LLC, Green Pointe, LLC, Life Dental Group, LLC, MHC Holdings, LLC, BTTP, LLC, CMTP, LLC, GATP, LLC, The Grove at Columbus, LLC, Shady Hills MHP, LLC and Cronos Ventures, LLC.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>Titan Leasing does not share with nonaffiliates so they can market to you.</i>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ▪ <i>Titan Leasing doesn't jointly market.</i>
Other important information	

California residents: We will not share your personal information with nonaffiliates for their marketing purposes, or with other financial companies for joint marketing purposes, except with your express consent. We will not share your personal information with affiliates if you instruct us not to using the opt-out methods described in this notice or any "Important Privacy Choices for Consumers" form that provided with this notice.

Vermont Residents: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
